Citizen Participation:

Mr. Dobson stated that he had been working on the parks walking trail and it needs cleaned up, holes fixed and get rubber fill for cracks and seal and that would cost \$7,000. TriState Paving in Comanche, Oklahoma would pave and chip the road around the park and would cost at \$16,000. Council stated that would have to be an agenda item for May. Mr. Cargill from the Comanche County Dist #4 was in the audience and stated that the County could do it under \$7,000. Mr. Dobson asked for wood or rubberized mulch under the playground equipment, it needed to be replaced. Mr. Dobson also stated that we needed to get the Ayers properties to deed the acreage they were giving to the City so we can get started on the park northeast of Cache.

Mia Tadanippa – Comanche County Tribal Committee stated that she appreciated all of the encouragement from the City and the participation on their grand opening of the Casino in the old Smoke Shop north of the highway. Was asking about the water and told them that was on the CKT rural side not the City of Cache. Gave her that information and again she thanked council for attending. Al Judd: Stated that he needed a letter to Comanche County for the sealing and repair of walking trail not to exceed \$1,000.

Ray Ortega on East B Avenue/ Deer and Antelope. Stated that the stop sign needed to be fixed and would like to have a sign to slow down the drivers because of the children playing in that area.

Ray Collins – Wildflower Circle. Stated that he had a handful of citizens concerned about the roads in need of repair. Council stated that we were working on that. Asked if there could be a speed bump and council stated no. Asked if it was against codes for homeowners to have business out of their homes. Council asked if they were conducting business and the homeowners had business that lived in the circle. That it was not a code violation for people to own businesses and have company vehicles on their properties. Mr. Collins asked about the animals and if it was zoned agriculture. City Attorney stated that it was zoned as residential and no animal inside the City of Cache. Stated that he had visited with many citizens with a petition wanting to have animals.

Joe Renedez: Asked Mr. Collins why he didn't stop at his house. That you walked right by it but didn't stop. (Almost a confrontation inside the chambers by these two).
