Councilman Lyon stated that he is getting complaints from the SRO Mike Crank. Ask if he was able to write tickets outside of the school grounds? Police Chief Phelps stated that by law he can write tickets on roads that were connected to the school grounds which included “H” Avenue or old highway 62. He is still a police officer, and the city holds his badge through CLEET but his duties from August 1 to May 31 is a school resource officer and explained those duties. Stated that next year that the school would be asked to establish their own police department and not from the city.




